The deadline for submission of technical and financial proposals is **6th November, 2023 at 11:00am** at, or before **1130 Hrs.** The proposals will be opened on the same day at **1200Hrs** in the presence of the firms/Specialists/Bidders or their representatives who choose to attend the meeting in the Office of the **Superintending Engineer, PWD Public Health Engineering Circle, Muzaffarabad.**

The selection process will be based on "Fixed Budget" as per PPRA rule 3E(i).

The consultancy firms/Individual Specialists/Bidders should send their proposals by courier or by hand in separate sealed envelopes clearly marked as "Technical Proposal" and "Financial Proposal" keeping both in one sealed envelope to above mentioned address. The bid security will have to be furnished in a sealed envelope enclosed in the Technical Proposal envelope & marked clearly as "**BID SECURITY**". In case of any discrepancy in the bid security, the Technical Proposal will be considered as non-responsive.

Proposal received after deadline of submission of bids will not be entertained.
