NOTICE FOR INVITING E-BIDDING

Single Stage-One Envelope E-Bidding System

The Govt. of AJ&K (The Employer) has allocated funds through "Normal Budget" towards cost of following project. It is intended that the part of the proceeds of the funds will be applied to eligible payments and the contract of the following work. Highways Division Bhimber Invites Electronic Bids in accordance with AJK PPRA Rules 36(a) Single Stage-One Envelope Bidding Procedure from the eligible Firms/Contractors/Persons licensed by the Pakistan Engineering Council for the year, 2023-24 and endorsement in PWD AJ&K department in appropriate category mentioned against work in column 5 below with **Specialization Code CE-01** for the following work. A Foreign bidder is entitled to participate in the bidding only if having a joint venture with any Pakistani Construction Firm in accordance with the relevant provisions of PEC by-laws. Bidders desirous to bid as Joint Venture must get prior approval by the Employer for bidding as joint venture.

Bidding is open to all Eligible Bidders

- 1 Bidding is open to all Eligible bidders / firms which are registered with C&W department for E-bidding.
- 2 Prospective bidders are required to get username and login detail from IT section, Office of The Chief Engineer Highway (North) Block H, DHQ Muzaffarabad. Bidders/Firms which are already electronically registered with the Department can use already provided username& Login.
- 3 Bidding Documents and instructions to Bidders can be downloaded up to 24 Hrs prior to the opening date from C&W website(www.cwd.ajk.gov.pk)
- 4 Bidders who submit their bids without a valid call deposit will be debarred from participating in bidding process for one year.
- 5 The bid securities of unsuccessful bidders will be returned upon award of the contract to the successful bidder or on the expiry of validity of bid, whichever is earlier.
- 6 Electronic Bidding shall be done on **percentage (Above/Below) Basis**. Only Two digits after the decimal point shall be considered for evaluation purpose.
- 7 "Blacklisted Firms/Companies/Suppliers/Distributors/Contractors/Bidders are prohibited for participation" and all bidders shall furnish an affidavit/certificate that they are neither blacklisted nor in conflict with Govt. anywhere in territory of the state of AJK, federally administrated areas or Islamic Republic of Pakistan.

- 8 Electronic Bids will be displayed through online E-Bidding system after 30 minutes of closing time in the presence of bidders/ their representative who choose be present.
- 9 Any Bidder (s) who provides incorrect information shall stand disqualified as per PPRA Rules.
- 10 The competent authority reserves the rights to reject all the bids or any bid under the Clause 33 of AJK PPRA Rules.
