TENDER NOTICE

The Employer, "Directorate of Sericulture GoAJ&K", intends to procure Fertilizers, Hybrid silkworm eggs packets against the development project *FARMERS TRAINING AND DEMONSTRATION OF PRODUCTS OF SERICULTURE DEPARTMENT IN AJ&K* under AJ&K PPRA rules from eligible Firms / Companies (Manufactures / Authorized Dealers / Suppliers duly registered / Endorsed with Tax department and Registrar of Companies / Firms of AJ&K) for the following works:-

- i) Seal bids are invited from the financially stable registered / endorsed firms / companies for Silkworm hybrid Eggs Supply and fertilizers.
- ii) Purchase of (Lot - A) Fertilizer (Urea), (Lot - B) Chinese Hybrid Silkworm Eggs packets (Imported) & Purchase/Distribution of Local/Hybrid Silkworm Eggs packets, on for basis at different localities in AJ&K.
- iii) A complete set of detailed documents of above work for specification and eligibility may be obtained by interested / eligible bidders on submission of a written application with payment of Rs.200/-.
- iv) Bidders may acquire Bidding Documents / detailed specifications of above mentioned work(s) from the Office of the Employer, during office hours, situated at "Custodian Building, behind Gillani Petrol Pump, opposite Old Secretariat, Muzaffarabad AJ&K (Ph. # 05822-920693)."
- v) Single Stage, one envelop procedure "AJK PPRA Rules" shall be opted for this procurement.
- vi) All bids must be accompanied with a Call Deposit of Rs. 180,000/- for (Lot- A) and Rs. 60,000/- for (Lot B) as a Bid Security/CDR and must also be delivered to Office of the Directorate of Sericulture, before 10:30 am on 06-02-2024, failure to do so shall amount to disqualification.
- vii) Bids will be opened at 11:00 am on the same day (06-02-2024) in the presence of bidders or their representatives, who may choose to attend, at the same address but once bids have been received (by hand or by post) are liable to be opened in Presence or Absence of bidder/representatives.
- viii) The employer reserves the right to accept or reject all or any of the bid in accordance with Rule 33 of AJKPPRA Rules 2017.
- ix) The employer reserves the rights to increase, decrease or eliminate any item(s) from the list offered for bidders as per PPRA Rule #42(c) (IV).
- x) As there are two lots of work (Lot "A") and (Lot "B"), hence contract can be awarded on lot wise
- xi) The Bill against procured items shall be paid to the successful bidder, after ensuring complete / safe supply of the work as per Supply Order issued by the Employer.
- xii) All taxes / charges from payable amount to successful bidder will be deducted according to the prevailing Laws of AJ&K Government.

- xiv) Bid evaluation report/ award of contract shall also be published on AJK PPRA official website.
