5. The offered rates will be applicable from date of issuance of supply order to till completion of supply by the supplier and no request for enhancement of rates will be accepted.
6. The supply will be made within the time specified in the Supply Order.
7. After delivery of consignment Inspection Committee will inspect the items according to the specification and if it is not accordingly, the supply will be rejected and lifted by the firm at its own risk and cost.
8. Quoted rates must be inclusive of GST; rates exclusive of GST will not be entertained.
9. All taxes/duties levied in AJ&K will be deducted from the total value of the bill at the time of the payment.

Black listed and banned Companies /Firms /Suppliers/Contractors/Bidders are prohibited for participation and all bidders shall furnish an affidavit/certificate that they are neither black listed nor in conflict with Govt. in any where in territory of the AJK, federally administrated areas or Islamic Republic of Pakistan.
