

The Bidding Document contains detailed specifications, instructions and conditions for those who intend to participate in the bidding process and are earnestly advised to read the Bidding Document before submission of their proposal / Bids which can be obtained through written application along with copy of PEC registration certificate to the undersigned on firm's letter Paid for a non-refundable cash payment of Rs. 1,000/- from the Office of the Directorate General Sports, Youth & Culture (Sports Stadium Muzaffarabad) till **20-05-2025** during the office hours.
2. All bids must be submitted in tape binding dully sealed.
3. Black listed Firms are prohibited for participation and all bidders shall furnish an affidavit / certificate that they are neither black listed nor in conflict with Government anywhere in territory of the State of the AJ&K, Federally Administrated Areas or Islamic Republic of Pakistan.
4. Call deposit for an amount 3% (Rs. 42,000) of the total value in favour of Director / DDO Sports, Youth & Culture Muzaffarabad Azad Kashmir should be accompanied with Financial Bid otherwise the offer will not be entertained.
5. Bid prices must be quoted on the relevant page of bidding document i.e., price schedule for the P/F of Thermopore to be offered, dully filled signed and stamped by authorize representative of bidder, supported by the bid security.
6. Samples of Thermopore Sheet must be required with bidding documents. After the complete installation, third party will check and verify the quality of Therma Pole. All expenses will be borne by the bidder.
