Tender documents can be purchased from the **Office Of Budget Officer Central Police Office Block No. 07 New Secretariat Muzaffarabad**, on any working day (Monday-Friday), during the office hours till **28th May 2025** after advertisement, in newspapers or on AJ&K PPRA website www.ajkPPRA.gov.pk, by submitting a written request on the firm/company letter head, along with a fee of Rs.2000 each (non-refundable).

Interested firms/ bidders may submit their bids in the office of the **Deputy Inspector General Police Headquarters Muzaffarabad**, along with a covering letter on firm's/ company's letter head, on or before 12:00 hrs. on **29th May 2025** positively. The bids will be opened on the same day at 12:30 pm, in the presence of bidders or their nominated agents present there. No tender document will be sold after **28th May 2025**.

1. The firms should be registered with sales tax/ CBR/income tax department.
2. Taxes will be deducted, as per applicable AJ&K Tax Laws & Government Rules, from the billed amount.
3. The Departmental Purchase Committee reserves the right to reject, all bid proposals, at any time, according to AJ&KPPRA Rules 2017.
4. The Departmental Purchase Committee shall, upon request, communicate to any supplier or contractor, who submits a bid or proposal, the grounds for its rejection of bids or proposal, but is not required to justify those grounds.

5. The Departmental Purchase Committee may decrease or increase the quantity as per AJ&K PPRA Rules 2017.
6. The Bidders have to deposit a soft copy of MS Power Point presentation and also catalogues/brochures of quoted items at the time of opening the tenders. Otherwise, the offers shall be ignored.
7. Black Listed Firms/Companies/Suppliers/Distributors/Contractors/Bidders are prohibited from participation. All Bidders shall furnish an affidavit/certificate that they are neither black listed nor in conflict with Government, anywhere in the territory of the state of AJK, federally administrated Areas or Islamic Republic of Pakistan.

Single stage one envelope bidding procedure shall be applied. The call deposit/ Earnest Money (Refundable) as mentioned against each item in the form of CDR in favor of **DDO Central Police Office Muzaffarabad**, is required to be submitted with the Financial Bid proposal, without which the offer shall be rejected being as non-responsive.

Note: All assessments and procuring procedures i.e., receiving, opening and awarding contract etc. shall be governed by the AJ&K Public Procurement Rules, 2017.; and the rates shall be valid within 120 days from the award of the contract.
