

NOTICE FOR INVITING E-BIDDING (L.A-17)
(Under Single Stage-Single Envelope E-Bidding System)


“Highways Division Haveli” Communication & Works, Govt. of Azad Jammu & Kashmir invites Electronic Bids in accordance with AJK PPRA Rules 36(a) as per Single Stage-Single Envelope Bidding Procedure & Rule 13 (1) (Emergency) from the eligible Firms/Contractors licensed by the Pakistan Engineering Council and having endorsement in C&W Govt. AJ&K for FY 2024-25 in appropriate category as mentioned in column 4 below with **Specialization Code CE-01 & Code CE-10** for the following works.

1. The newly registered bidders are directed to get username and login details from IT Section, Office of The Chief Engineer Highway (North) Block H, DHQ Muzaffarabad. Bidders/Firms which are already electronically registered with the Department can use already provided username & password.
2. Bidding Documents and instructions to Bidders can be downloaded from C&W website (www.cwd.ajk.gov.pk).
3. All bids will be opened & shown electronically & comparative statement will also be visible to all participants at 12:00 pm on same date.
4. The interested bidders shall upload scanned copy of Bank Receipt showing proof of deposit of Bid Security in the Divisional Joint Account, A/C # 038-12548001 BAJK Haveli (Kahutta) Branch along with their relevant documents on its Dashboard.
5. The bid securities of unsuccessful bidders will be returned through Divisional Cheque upon award of the contract to the successful bidder(s) or on the expiry of validity of bid, whichever is earlier.
6. Electronic Bidding shall be done on **percentage (Above/Below/At par) Basis**. Only Two digits after the decimal point shall be considered for evaluation purposes.
7. Blacklisted Firms/Contractors/Companies/Suppliers/Distributors are not allowed to participate in the bidding process. The interested bidders shall furnish an affidavit/certificate that they are neither blacklisted nor involved in conflict with Govt anywhere in territory of the state of AJK or federally administrated areas/all provinces of Islamic Republic of Pakistan.
8. Hard copy of Original Bank Receipts along with Bidding Documents (uploaded by Highways Division Haveli duly signed & stamped by the Contractor/Firm must be submitted in the relevant office of the Executive Engineer Highways Division Haveli within 48 hours after opening of bid through E-Bidding system.
9. The interested bidders shall upload only Letter of Bid of the Firm/Contractor, other documents required for qualification/responsiveness as per Bid Data Sheet and BOQ on E-Bidding Dashboard. The remaining data/particulars shall be submitted in shape of hard copy along with uploaded pages within 24 hours after opening of their bid(s). Otherwise such bidder/bidders will be declared as disqualified.
10. Any Bidder(s) who provides incorrect information or does not submit hard copies of complete bidding documents including documents uploaded on its dashboard shall stand disqualified and shall be banned for two years for participation in any type of bidding procedure.
11. The competent authority reserves the rights to reject all or any bid under the Clause 33 of AJK PPRA Rules.
