

## Corrigendum

### “Hiring of Training Providers for Technical and Vocational Trainings to the youth of AJK”

The Azad Government of the state of Jammu & Kashmir has established an Endowment Fund for Skill Development in AJ&K under the management of AJK-TEVTA to promote state of the art technical education to the unemployed youth of Azad Jammu & Kashmir to address the rising issue of unemployment in the State.

The AJK-TEVTA will meet the Training cost and Boarding & Lodging cost of the candidate, whereas interested Training Providers will be responsible for providing quality training and ensure employability after completion of training. The interested Training Provider shall submit its organizational profile till closing date i.e., 16<sup>th</sup> May 2025, before 14:00 hrs. The organizational profile will be evaluated on criteria as described below.

- Has a registered as Training Institutions or industrial facilities or University(ies) in Pakistan with relevant experience as Training Provider.
- has valid Registration of National Tax Number (NTN), must provide copy of registration certificate and also submit ALT report (if Filer);
- Must be involved in the business of Skill Training and having dedicated space for both theoretical and practical work.
- Must have minimum turnover more than 20 million in last two years.
- Must be affiliated with approved and accredited Qualification Awarding Body for Certification of Trainees on the completion of Training Program.
- Training can only be delivered in “Approved Trades / Qualification” from relevant Competent Authority.
- The RFP document will be provided to short-listed Training Providers.
- AJK-TEVTA intends to invite Request for Proposal (RFP) as per criteria given in RFP document in accordance with Regulation 8 of AJ&K PPRA Consultancy Regulation, 2018 from the TVET sector Institutes working in public and private sector in Pakistan to provide technical education to the youth of AJK.
- The interested Training Provider from private sector shall furnish Earnest Money of Rs. 200,000/= (two hundred thousand rupees) along-with financial proposals in the form of Call Deposit Receipt (CDR) in favor of AJK-TEVTA otherwise Proposals shall stand rejected.
- All interested Training Providers must submit detailed Organizational Profile either by registered courier or through authorized representative to “**Director (Projects), AJK-TEVTA Complex, Jalalabad Muzaffarabad, Azad Jammu & Kashmir**” till 16<sup>th</sup> May 2025 on or **before 14:00 hrs**, which will be opened at 15:00 hrs on same day.
- The document received after closing date and time will not be considered and delivered back unopened.
- The bidders are requested to give their best and final prices as no negotiations are expected.
- Taxes will be deducted as per applicable government rules from billed amount.
- Black listed Firms / Companies / Suppliers / Distributors / Contractors / Bidders are prohibited for participation” and all training providers shall furnish an affidavit / certificate that they are neither black listed nor in Conflict with Government anywhere in territory of the State of the AJK, federally administrated Areas or Islamic Republic of Pakistan. (Submission of undertaking on legal stamp paper is mandatory).
- AJK-TEVTA reserves the right to accept or reject any bid under Rule 33 of AJ&K PPRA Rules, 2017.
- Bid Evaluation Report (Technical and Financial) / Award of Contract shall also be displayed at AJK PPRA website.
