- The Employer now invites sealed bids under the **"Single-Stage, Single-Envelope"** procedure from eligible and experienced contractors, duly licensed by the Pakistan Engineering Council (PEC) for the year **2025-26** in Category **C6** or **above**. Bidders must demonstrate relevant experience in **Hydel Projects** and /or **Power Stations**.
- A complete set of Bidding Documents may be purchased on payment of prescribed **Tender Fee (non-refundable i.e. above mentioned)** for each work on payment of cash amount by interested eligible bidders along with submission of a written application on the Official Letter Head of Firm to **Deputy Director Civil AJK-PDO** upto **03.11.2025** at **4.8 MW Battar Power House District Haveli**,
- Bid must be accompanied by **Bid Security** mentioned against work in the form of Bank Draft or Call Deposit Receipt (CDR) from any schedule Bank of Pakistan on the Bid Security Form included in the Bidding Documents in the name of **Deputy Director Civil AJK-PDO**.
- Sealed Bid shall be submitted at the Site Office of **Deputy Director Civil AJKPDO**, at **4.8 MW Battar Power House District Haveli** on **04.11.2025** at **12:00pm**. Bids shall be opened on the **Same day** at **12:30pm** in the presence of bidders representatives who choose to attend.
- Bidding Documents will be issued only to the **Contractor / Firm** or their **Authorized Representatives** who will show the original **Power of Attorney** along with **Original Authority Letter**.
- Original PEC Licence** must be presented at the time of purchase of **Bidding Documents**.
- "Blacklisted firms /Companies/Contractors and Bidders are prohibited for participation"** and all bidders shall furnish an **Affidavit on Stamp Paper of Rs. 50/-** ensuring that they are nor blacklisted nor in conflict with the Government anywhere in territory of the State of AJK
- All CDR's except of successful bidder shall be released after due verification. No CDR will be released on the bidding day.
- Conditional, incomplete and bid filled with led pencil will not be acceptable.
- The Competent Authority in accordance with PPRA Rules-33 reserves the right to reject any bid or all Bids at any time prior to the acceptance of bid.
- The works will be executed as per requirement.
