Interested experienced applicants may apply for issuance of bidding documents against payment of separate prescribe tender fee (non-refundable CDR) for each of the work lot along with written application in favor of undersign along with copy of valid PEC registration copy. Bidding documents shall be issued to owners/authorized representatives after fulfilling requisite formalities.
3. Incase of joint ventures, maximum number of firms shall be two.
4. Bidders may purchase bidding documents for all packages/lots, but shall be eligible to submit a bid for only one package/lot of their own choice. Submission of bids for more than one package/lot by the same bidder will result in disqualification of all bids submitted by that bidder.
5. Last date for purchase of bidding documents is 7th January, 2026 (4:00 pm).
6. Bid security of prescribed amount shall be submitted along with technical bid at the time of bid submission in favor of undersign. Bid security shall be in the form of bank guarantee on prescribed form in bidding document or Call deposit receipt (CDR) issued from any Schedule bank of Pakistan.
7. Bids shall be submitted in office of undersign on 8th January, 2026 on prescribed time as stated above through firm/company owner/authorized representatives. Technical bids shall be opened 30 minutes after bid submission time.
