TERMS & CONDITIONS:

- i) Sealed bids shall be submitted to the Directorate General Sports, Youth & Culture, Sports Stadium Muzaffarabad Azad Kashmir, on or before **30th April, 2026** till **11:00am**. The bids shall be opened on same day at **11:30am** in the presence of bidders or their authorized personnel who may choose to attend the bids opening meeting.
- ii) A complete set of Bidding documents including detail specifications, Quantity, terms & condition & Evaluation Criteria can be obtained through authorized person from the office of Directorate General Sports, Youth & Culture, Sports Stadium Muzaffarabad upto **29th April, 2026** (till office hours) on submission of written request upon payment of **Rs. 1,000/- (Non-Refundable)**.
- iii) Bidders shall quote rates inclusive of all taxes applicable either local or national.
- iv) Bidders shall quote item-wise rates and total price of Lot.
- v) Bid security (CDR) of Rs. 37,050/- For LOT # 01, Rs. 9,300/- for LOT # 02 and Rs. 10,800/- for LOT # 03 in favor of "**DDO Sports, Youth & Culture Muzaffarabad**" must be attached with each bid. Without Bid Security, bid shall not be entertained.
- vi) Validity of Bid Security period should not be less than 90 days.
- vii) Bid shall remain valid till **30th June, 2026**.
- viii) All bids should be submitted in Tape Binding duly sealed.
- ix) Black listed Firms / Companies / Suppliers / Distributors / Contractors / Bidders are prohibited for participation. Bidders shall furnish an affidavit certificate that they are neither blacklisted nor in conflict with Government anywhere in territory of the State of Jammu & Kashmir, Federally administrated areas of Islamic Republic of Pakistan.
- x) Evaluation Report & Award of Contract shall also be published on AJK PPRA Website.
- xi) Competent Authority reserves the right to accept or reject any or all bids in light of Rule-33 of AJK Public Procurement Rule (PPRA) 2017.
