**NOTICE FOR INVITING E-BIDDING**

(Under Single Stage-Single Envelope E-Bidding System)

The Govt. of AJ&K (The Employer) has allocated funds through "Normal Budget" towards cost of following projects. It is intended that the part of the proceeds of the funds will be applied to eligible payments and the contract of the following works. Highways Division Kotli Communication & Works, Govt. of Azad Jammu & Kashmir invites Electronic Bids in accordance with AJK PPRA Rules 36(a) as per Single Stage-Single Envelope Bidding Procedure from the eligible Firms/Contractors licensed by the Pakistan Engineering Council and having endorsement in C&W Govt. **AJ&K for FY 2025-26** in appropriate category with specialization code as mentioned against each work in column 5 below.

- 1- The newly registered bidders are directed to get username and login details from IT Section, Office of The Chief Engineer Highways (Muzaffarabad) Block H, DHQ Muzaffarabad. Bidders/Firms which are registered with E-Bidding in the Department can use already provided username & password.
- 2- Bidding Documents and instructions to Bidders can be downloaded from contractor's dashboard.
- 3- Interested bidders who have submitted their Electronic Bid(s) upto due date & time mentioned in column 7 above, will be opened as per schedule and at the same time the comparative statement will be visible to the Bidders or their nominated representatives & Bid Opening Committee.
- 4- The interested bidders shall upload scanned copy of **Bank Receipt or CDR** showing proof of deposit of Bid Security as mentioned in column-6 above, in the Divisional Joint Account

along with their relevant documents on its Dashboard.
- 5- Performance security is fixed as 5% of bid price. However, Any Contractor/ Firm, who quotes its rates below than 10% of Engineering Estimates, shall submit additional Performance security equal to 5% of its bid price in the light of clause#39 of AJK-PPRA Rules. The Contractor/Firm shall submit this performance security in form of CDR or unconditional on demand bank guarantee from scheduled bank of Pakistan having its branches in AJK or Bank of AJK as amount mentioned in Letter of Acceptance.
- 7- Electronic Bidding shall be done on percentage (Above/Below/At par) Basis. Only Two digits after the decimal point shall be considered for evaluation purposes.

- 8- Blacklisted Firms/Contractors/Companies/Suppliers/Distributors are not allowed to participate in the bidding process. The interested bidders shall furnish an affidavit/certificate that they are neither blacklisted nor involved in conflict with Govt. anywhere in territory of the state of AJK or federally administrated areas/all provinces of Islamic Republic of Pakistan.
- 9- Hard copy of **Original Bank Receipts or CDR** along with Bidding Documents (uploaded by Highways Division Kotli) duly signed & stamped by the Contractor/Firm must be submitted in the relevant office of the Executive Engineer Highways Division Kotli within 48 hours after opening of bid through E-Bidding system.
- 10- The interested bidders shall upload only Letter of Bid of the Firm/Contractor, other documents required for qualification/responsiveness as per Bid Data Sheet and BOQ on E- Bidding Dashboard. The remaining data/particulars shall be submitted in shape of hard copy along with uploaded pages within 48 hours after opening of their bid(s). Otherwise such bidder/bidders will be declared as disqualified.
- 11- In E-Bidding System, the software supports only PDF file Format for Technical Profile uploading option, therefore interested bidders shall upload their Technical Profile in PDF file format only.
- 12- Any Bidder(s) who provides incorrect information or does not submit hard copies of complete bidding documents including those documents uploaded on its dashboard, shall stand disqualified and shall be banned for two years for participation in any type of bidding procedure.
- 13- In case of any disturbance or fault in internet or electricity supply the proposed date of Bid opening would be the next day with one hour difference as per proposed time.
- 14- The competent authority reserves the rights to reject all or any bid under the Clause 33 of AJK PPRA Rules.
