

### TENDER NOTICE

Office of the "Directorate of Industries & Commerce, GoAJ&K", intends to procure Furniture for the development project "UPLIFTING OF INDUSTRIES & COMMERCE DEPARTMENT FOR PROMOTION OF INDUSTRIALIZATION IN AJ&K" under AJ&K PPRA rules. Eligible firms /companies (manufactures, authorized dealers, or Suppliers registered with the Tax department and Registrar of Companies /Firms of AJ&K) are invited to bid for the above work: -

- i) Sealed bids are invited from the financially stable, registered and endorsed firms /companies for the supply of furniture's.
- ii) A complete set of detailed documents, including specifications and eligibility criteria, can be obtained by interested and eligible bidders upon submission of a written application and payment of Rs.800/- from the office during office hours at "Directorate of Industries & Commerce Industrial Estate Chella, Muzaffarabad AJ&K (Ph. # 05822-923176)."
- iii) The procurement will follow a Single-stage, one-envelope procedure under the "AJK PPRA Rules".
- iv) All bids must be accompanied by a Call Deposit 2% of the quoted rates as Bid Security.
- v) Bids must be delivered to the office of the Directorate of Industries & Commerce by 10:30 am on 25<sup>th</sup> May, 2026. Late submission will result in disqualification.
- vi) Bids will be opened at 11:00 am on the same day at same office in the presence of bidders or their authorized representatives who may choose to attend, at the same address.
- vii) Once bids are received (either by hand or by post) they are liable to be opened regardless of the presence of bidders or their representatives.
- viii) The Employer reserves the right to accept or reject any or all bids in accordance with Rule 33 of AJKPPRA Rules 2017.
- ix) The Employer also reserves the rights to increase, decrease or eliminate any item(s) from the list offered to bidders as per PPRA Rule #42(c) (IV).
- x) Payment to the successful bidder will be made after ensuring the complete and safe supply of the work and Goods Received and Inspection report as per the supply order issued by the Employer.
- xi) All applicable taxes and charges will be deducted according to the prevailing laws of the AJ&K Government.

- xiii) The bid evaluation report and award of the contract will be published on AJK PPRA official website.
- xiv) The successful bidder shall be bound to furnish 8% performance security in shape of bank draft in the favor of employer, before issuance of supply order.
