Bidding documents will be issued only to Firms (s) or their representative (s) having licensed by the Pakistan Engineering Council in the category C-6 and above for the mentioned work and should be duly enclosed by the Office of the Executive Engineer MCM At Muzaffarabad having validity for FY 2025-26 who will submit original power of attorney along with original authority letter on stamp paper of Rs. 500/- with each page attested by the Oath Commissioner.

In case the bidders quoted their rates 10% or more than 10% below Engineering Estimate, will have to provide additional bid security along with their bid in the shape of CDR or Bank Guarantee from any scheduled Bank of Pakistan / AJK equal to the amount of difference between the estimate and bid costs. Failure to do so will result in non-responsiveness.
8. The bids must be submitted in two sealed envelopes separately marked as "Technical" and "Financial" bids with single outer envelope in the below mentioned address.
9. Black listed Bidders are not allowed to participate in the bidding.
